

The courts have dealt gently with cases coming from Justices Courts, evidently feeling it their duty to try to keep them in existence until they could be properly nourished by legislative enactment. The reforms I would suggest are these: (1) Put all Justices of the Peace on a salary basis. (2) Make the Justices of the Peace at the county site trial justices only. The Justices of the Peace in rural districts shall be peace officers, rather than judges. (3) Prescribe qualifications for holding the office of justice of the peace. Require that the justice of the peace at the county site shall be a lawyer. Require that the justice of the peace in the rural districts shall have some knowledge of the law. (4) Have the Justice of the Peace at the county site appointed by the judge of the Superior Court, and the Justice of the Peace in the rural districts appointed by the judge of the City or County Court. (5) Increase the jurisdiction from 100. 00, including attorneys fees to 100. 00 exclusive of interest and attorneys fees. (6) Give the court jurisdiction of all classes of actions where the amount involved does not exceed 100. 00 exclusive of interest and attorneys fees, including damages to realty and all tort actions. (7) Hold semi-monthly sessions and allow five days for service of the summons upon the defendant. (8)...
